A minimum of eight years teaching and research experience in an academic position equivalent to that of Assistant Professor in a University or College with a minimum of seven publications in peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria as per the UGC Regulations, 2018.

2. Assistant Professor of Law

- A. A postgraduate degree (2 year LL.M degree) in Law from a recognized institution with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed). If the candidate has a one year LL.M. Degree then, the candidate must have a post qualification after LL.M.
- B. The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET subject to following exemptions:
 - i. Ph.D Degree holders will be preferred.
 - ii. Provided, candidates who have registered for the Ph.D. programme prior to July 11, 2009, shall be subject to the fulfillment of the following conditions:
 - a. The Ph.D. degree of the candidate has been awarded in a regular mode;
 - b. The Ph.D. thesis has been evaluated by at least two external examiners;
 - c. An open Ph.D. viva voce of the candidate has been conducted;
 - d. The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
 - e. The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

3. Assistant Professor of Management

- A. A postgraduate degree in Management Studies from a recognized institution with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- B. The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET subject to following exemptions:
 - i. Ph.D Degree holders will be preferred.
 - ii. Provided, candidates who have registered for the Ph.D. programme prior to July 11, 2009, shall be subject to the fulfillment of the following conditions:-

- a. The Ph.D. degree of the candidate has been awarded in a regular mode;
- b. The Ph.D. thesis has been evaluated by at least two external examiners;
- c. An open Ph.D. viva voce of the candidate has been conducted;
- d. The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
